

## BWAGA-MOYO - LAY DOWN YOUR HEART!///







It was the first major Gospel meeting and the first large Christian event in Bagamoyo, a city in Tanzania with a strong Muslim influence. In January, Evangelist Schott came to this historically significant port city - the former capital of German East Africa.

Even before going to the hotel after a long journey, a visit to the local museum was on the itinerary. The museum guide provided an excellent overview of the history of Bagamoyo, which is inextricably linked to the cruel slave trade. The city used to be both a trading port for slaves and a starting point for expeditions by European explorers. The name Bagamoyo is derived from "Bwaga-Moyo". In Swahili it means "Lay down your heart." This is because slaves who arrived in the port city would never see their homes again.

"Bwaga-Moyo" was to take on a different meaning this weekend. People would lay down their hearts, before Jesus. Evangelist Schott preached the Gospel in the power of the Holy Spirit. Hundreds received forgiveness of their sins, some for the first time – including Muslims. Many healings and testimonies followed. For example, a woman reported that a baby-sized tumor had disappeared after ten years. In the prayer tent, a witch was delivered from demons. The power of the Holy Spirit was present and changed the people of Bagamoyo.





## WAR IS CRUEL AND LEAVES TRACES!////

In March, Daniel Schott flew to Juba (South Sudan) and met with evangelist Enoka Dumo, one of the leaders of the revival movement within the Anglican Church. Together, they met with people of high rank and importance, from both the church and government. Evangelist Schott preached twice on radio *Capital 89.0 FM* reaching the capital city. He also served at a leadership conference in Juba. This was followed by a courtesy visit to a mass grave in Kajokeji. After a brief speech, Daniel took the opportunity to lead those present in a prayer of surrender. Finally, the team traveled by car across the border to Moyo, in Uganda.

War is cruel and leaves traces! Long after a conflict has been taken off the headlines, people must deal with their post-war everyday life! The Kuku tribe had fled across the border into Uganda because of the war in South Sudan. In cooperation with the UN, the refugees were allowed to settle in the northern border region of Uganda. Not in a fenced camp, but in a settlement – as was emphasized by a government official. Although the South Sudanese are granted the same rights as the Ugandans, poverty prevails. These people have left everything and live as refugees – some for the second time. Many are still dependent on food rations from the *World Food Program*. Young people are often unemployed and live sinful and criminal lives.

Evangelist Enoka Dumo saw the great need and invited Daniel to train and encourage Christian leaders. Initially, 200 selected leaders from the settlement were supposed to participate in the training, but in the end there were around 300 attendees.

Special permissions were required for Evangelist Schott to enter the refugee settlement, especially since he was coming from abroad. Despite the preparations in advance, the team encountered significant problems while registering with the settlement leader. It went "from pillar to post". After five hours, and after many discussions and waiting at different offices, Daniel was finally allowed to enter.

As the off-road vehicle finally approached the venue, the team was greeted by an enthusiastic crowd. With singing, dancing, and joyful waving of branches, the evangelists Enoka Dumo and Daniel Schott were led to the church.

The sessions on Friday and Saturday were intense. Evangelist Schott spoke on the topics of revival, calling, and evangelism. The Holy Spirit was at work, and the leaders repented. At the end of one teaching session, one of the retired bishops prayed and broke into loud sobbing. Tears flowed in the church. The wounds and the desire for revival and restoration of their country run deep.





















The leadership training ended on Saturday. On Sunday, Evangelist Schott was asked to preach at the open-air service. It was a very formal Anglican church service, and it was opened by the *Residence District Commissioner*.

As the evangelist preached, the service turned into a Gospel meeting for a while. Hundreds received forgiveness of their sins, and more than 50 people were healed. After a very long service, Evangelist Schott was invited to lunch with other leaders. One of the specialties of the Kuku people was

served this Sunday: rat meat – which is believed to have medicinal properties.

On Monday, the team first crossed the border back into South Sudan and then flew back to Juba, in a packed Cessna. The leaders who stayed behind had learned a lot and experienced the presence of the Lord. They would bring the Gospel to their respective areas with new hope and perspective - even to the war-torn regions of South Sudan.







## EUROPE ALSO NEEDS REVIVAL!///

In January, Daniel accepted an invitation to speak in Switzerland. He was a guest speaker at the *Prophetic School of Ministry* led by Apostle John E. Sagoe at the *New International Church* in Biel.

The atmosphere was charged with excitement. Evangelist Schott preached about not limiting the work of God and about the supernatural power of the Holy Spirit. He emphasized that God uses ordinary people who are surrendered to the Holy Spirit. The Lord confirmed the evangelist's ministry with supernatural manifestations of His power. Revival is in the air. There is hope for Europe!
